1. Access & payment

1.1 Access and use

By participating in *The Stages of the Path to Enlightenment Course* you agree to the following terms of use. Roman Angerer reserves the right to change these terms, but only after prior request and notification. By remaining in the event series after an update, you agree to the terms of the update.

1.2 Registration

Registrations are binding (under restriction by 3. Cancellation & Guarantee) and can be made via the registration form or by personal contact with Roman Angerer; in case of overbooking the chronological order of receipt application applies as criteria for successful registration. Our courses require a normal physical and mental capacity, the participants take part on their own responsibility. The courses are not a substitute for therapy or supervision.

After registration you will receive a confirmation of registration. The invoice for the series of events will follow within the first weeks of the course. The amount has to be paid in full after the second event at the latest (or in case of partial payment according to the agreed deadlines - see partial payment), otherwise participation is not possible.

1.3 Cancellation & Guarantee

Until one week after the second event the registration can be cancelled, in which case a proportional fee for the first two events has to be paid, which means: $\frac{Price}{14} \times 2$. In case of later cancellation, the full amount is due unless a different agreement is made for personal reasons.

1.4 Cancellation by Course Leaders

Should the event series be cancelled by Roman Angerer, we will refund the proportional paid invoice amount. Further claims (accommodation/travel) cannot be asserted.

1.5 Cancellation by Participants

In case of cancellation of a course by the participant, no refund is possible and the total amount due will be charged unless otherwise agreed for personal reasons.

1.6 Partial payment

We offer the possibility to pay in monthly installments. All installments are due at the start of the month. In the event of discontinuation of the training or default of payment, the entire outstanding amount will be due.

1.7 Invoice dispatch

By default, the invoice is sent as a PDF file by e-mail or our social media platform.

1.8. value added tax free

Our service is VAT free.

1.9 Additional costs?

With the payment of the fees, you get access to our learning environment. The course fees include the costs for the rental of the learning environment, Zoom sessions and for your evaluation, coaching, and the rental of the seminar room on the final weekend during the course.

You are responsible for the cost of connecting to your Internet service provider and for the cost of any phone calls to Zoom meetings. These calls may or may not be to destinations outside of your country.

Zoom events are recorded. These recordings will be stored for your use, and you agree that Roman Angerer may create the recordings and make them available internally in the learning environment. The videos are made available via Vimeo embedding where they are listed under private settings, i.e., they cannot be found via search engines or Vimeo, but only via the link provided.

Sharing with third parties will be considered a violation of the privacy of all participants and will result in the suspension or cancellation of your course without refund.
